


FY 2024 4th Quarter Development Activity Report July-September



Department Updates

- Conducted a walk through and established a punch list for the new Development Services Building with Parks and Recreation Department at 2140 S Riverside Drive.
- Coordinated with Lennar, D.R. Horton, and the Miami Corporation for the use of Vacuum trucks to help clean out culverts in Florida Shores after the rain event on September 14th.
- Coordinated with Lennar to work on the stormwater system for the Parks at Edgewater Phase 2 in advance of Hurricane Milton.
- Drafted two moratoriums in collaboration with the City Attorney to be presented to City Council.
- Established an email, flood@cityofedgewater.org, to allow residents to submit flooding images in an effort to help document and map where flooding is occurring in the City of Edgewater.
- Coordinated with Lennar and their contractor, the Briar Team, to stage an 8" pump at the canal near Veterans Park to facilitate the draw down of stormwater during Hurricane Milton.
- Coordinated with the Code Enforcement Division to conduct a damage assessment from Hurricane Milton with Planning and Building staff on Friday, October 11^{th.}




